PATRON MEMBERSHIP TERMS AND CONDITIONS

ASSUMPTION OF RISK AND LIABILITY WAIVER AND RELEASE AND INDEMNITY AGREEMENT ("RELEASE") I, the Patron (also referred to as member), on my own behalf, and behalf of all others listed as Patrons under this Agreement, including my, and their unborn and/or minor children, and my, and their personal representatives, assigns, successors, heirs, and next of kin, (collectively referred to as the "Participants"), acknowledge and agree that the use of the facilities, services, equipment or premises (hereinafter collectively referred to as the "facilities") of Mohawk Golf Club by any of the Participants involves risk of injury to persons and property, and the Participants assume full responsibility for such risks for myself/themselves. Such facilities include, but are not limited to social activities, educational activities, pool, locker rooms, showers, sidewalks, parking lots, stairs, lobby area, or rest rooms. Such risk of injury includes, but is not limited to injuries arising from the participation by any of the Participants, or others, in supervised or unsupervised activities at Mohawk Golf Club, injuries and medical disorders, including, but not limited to death, heart attacks, strokes, heat stress, sprains, broken bones, and injured muscles and ligaments, among others, arising from exercising, any use of any of MGC's facilities, or otherwise, or while participating in any of MGC's programs, classes, or activities, and accidental injuries occurring anywhere in or about the Mohawk Golf Club. The Participants agree and acknowledge that I/they have entered into the Agreement for use of the MGC's facilities primarily for recreational purposes and not for a specific piece or type of equipment or training methodology. In consideration for being permitted to enter the MGC for the purpose of using the facilities, the Participants hereby release MGC and its owners, directors, officers, shareholders, members, managers, parents, subsidiaries, employees, volunteers, independent contractors, agents, and insurers (hereinafter collectively referred to as "Released Parties") from any and all liability to the Participants as a result of any loss, damage or injury sustained by any of the Participants. The Participants hereby waive any claim or demands therefore based on, or on account of, any injury or death to any of the Participants, or property damages sustained by any of the Participants, whether caused by the active or passive negligence, concurrent or otherwise, of the Released Parties, the Participant, or others, while any of the Participants is in, upon, or about MGC's premises, or while using MGC's facilities or while participating in any MGC activity at any location, including off-site activities. The claims and demands so waived include but are not limited to, claims based on: improper maintenance of equipment (mechanical or otherwise), grounds or facilities; negligent hiring, instruction or supervision, including personal training, inadequate security or staffing; the Participants' use of the MGC's facilities; and/or slipping or tripping anywhere in or about MGC or any location in which MGC operates, including, but not limited to public facilities. The Participants further expressly agree that this Release is intended to be as broad

and as inclusive as permitted by the law of the State of New York, and that if any portion of the foregoing Release is held invalid by a court of law, then that portion shall be deemed stricken and it is agreed that the remainder of the Release shall continue in full force and effect without the invalid portion. I acknowledge that I have carefully read this Release and fully understand and agree that by executing this Release, I, and all Participants forfeit any rights they or I may have to bring legal action against the Released Parties for their active or passive negligence, concurrent, or otherwise, arising out of my/their use of MGC. I represent that I am at least 18 years of age, and have actual authority to, and do hereby enter into this Release on my behalf and on behalf of all Participants by signing below. I have carefully read and voluntarily signed this Release and I further agree that no oral representations, statements or inducement apart from the foregoing Release have been made to me. I have read and agree to be bound by the terms of this Patron Agreement, including the Patron Terms and Conditions on the reverse side hereof, and I acknowledge that a complete copy of this Patron Agreement was provided to me when the Patron Agreement was signed. I further agree to be bound by the MGC's Rules and Regulations.

ADDITIONAL TERMS AND CONDITIONS TO PATRON AGREEMENT

- 1. Patron/Member Renewal/Cancellation. This Patron Agreement is valid for 12 months as of the date of the signed Agreement. After the initial membership period has expired, this Patron Agreement will automatically renew on a yearly basis on the terms and conditions stated in this Agreement. Patron is responsible for payment of all dues and charges for the entire length of this Patron Agreement.
- 2. **Patron/Member Rights and Limitations**. This Agreement permits Patron to use MGC's facilities in accordance with MGC's rules. This Agreement is non-transferable, non-assignable, and does not provide Patron with any legal or financial rights or interests in MGC, its assets, property, operation, or management.
- 3. **Rules**. Patron agrees to read and abide by MGC rules, additional rules and acknowledges receipt of a copy of the current MGC Rules. The MGC reserves the right to amend the MGC Rules from time to time in its sole and absolute discretion. The failure of Patron or Patron's family to follow these rules may result in cancellation of the membership.
- Governing Law. This Patron Agreement shall be construed and enforced in accordance with the laws of the State of New York.
- 5. **Entire Agreement**. This Agreement constitutes the entire agreement between the MGC and Patron(s) and may be altered or amended only by a written instrument signed by the Patron and an authorized MGC

representative.

- 6. **Monthly Dues**. The monthly dues are payable on the first day of each month. Failure to pay Dues on time may result in a late fee. MGC reserves the right to increase dues from time to time upon no less than 30-day advance written notice to the Patron.
 - If a member is 45 days or more later with their payment, the member is suspended.
- 7. Cancellation Upon Death or Disability. If by reason of death or disability, the member is unable to receive all services for which the member has contracted, the member and his/her estate shall be relieved from the obligation of making payment for services other than those received prior to death or the onset of disability, and that if the member has prepaid any sum for services, so much of such sum as is allocable to services the member has not taken shall be promptly refunded to the member or the member's personal representative upon request. "Disability" means a condition which precludes the member from physically using the facilities and the condition is verified by a physician.
- 8. Physical Condition/No Medical Advice. All Patrons individually represent that he/she has no known medical condition or impairment that might prevent Patron from his/her intended use of the MGC's facilities and services. Patron acknowledges that MGC did not provide Patron with any medical advice at any time relating to Patron's physical condition and Patron's ability to use the MGC's facilities and services. If Patron has any medical concerns, those concerns should be discussed with Patron's personal physician before Patron uses MGC's facilities and services.
- 9. **Patron/Member Classification**. Patron classifications shall be defined as follows for purposes of this Agreement:

Single Patrons are issued to one individual. This individual may be a minor, provided that a parent or legal guardian executes this Patron Agreement on his or her behalf and agrees to be financially responsible for all sums due hereunder.

2022 MINIMUM CATERING CHARGE

Food and Beverage Minimums: Minimums apply to all member categories. They may be used for food and/or beverages at any location of the Mohawk Golf Club. They cannot be used in any capacity with any reciprocal agreements.

Time Period: Minimums are billed on the calendar month from February to November. The Snowbird Option allows any member category to pay their minimum, as noted in the chart, during May – November. Prepayment is also an option. Any member, or family, may prepay their F&B minimum for the year. The prepaid amount can be used at any point during the year. There is <u>NO</u> reimbursement, transfer, rollover, or credit for unused minimum balances. Each calendar year the minimum begins again.

Forgiveness: There shall be no forgiveness except for documented medical reasons, verified by the certified physician, that restrict the member's use of the Club for an entire calendar quarter. Such requests will be considered by MGC upon receipt of written notification accompanied by the appropriate medical documentation.

GENERAL RULES

Only members, their families, their guests and employees shall be admitted to the Clubhouse or to any of Mohawk Golf Club's facilities. Members' children 16 years of age or over may use the Club's recreation facilities only if the family or individual hold appropriate memberships to their age or are registered as guests of members who pay the established guest fees.

Members or guests should not attempt to give the staff and employees directions contrary to the established Rules or Policies, or to reprimand employees. Suggestions or recommendations for changes and improvements in Club Rules and Policies should be made in writing, addressed to the proper manager.

Club Advisory Teams

Advisory Teams will serve to assist management in various club operations. The goal is to provide insight into historical processes and offerings that benefit club members and families. Please reach out to management with interest in participating – there are only a limited number of spots for each team.

Guest Policies

Guest passes only apply to guests – they may <u>not</u> be used by the member for their own play. Local Resident Guests may be admitted for the use of the Club's recreation facilities (golf, tennis, swimming) for a period of one day upon the invitation of a member, but an individual local resident shall not be admitted for the use of any one of these facilities more than *three times in one calendar year*.

Guests admitted for the use of either the house or recreation facilities must be accompanied by the member extending the invitation, or by a member of the latter's family having Club privileges, except that Non-Resident Guests may use the dining facilities without being so accompanied when advance arrangements are made.

Members inviting guests for the use of the Club's recreation facilities must register the guests for each such facility used and are responsible

for the payment of the established guest fees.

Members are responsible for the conduct of their guests. Members shall be charged for all damage to MGC property caused by themselves, their families and their guests and for all services rendered.

No member or guest shall remove from MGC property any article belonging to MGC without permission.

Mohawk Golf Club will exercise ordinary diligence in protecting the property of members and guests, but it will not be responsible for any loss. All such property is at the owner's risk.

Members and guests shall park only in the assigned areas and proper parking, between lines, is requested. Parking in unauthorized spots may result in towing at the vehicle owner's expense.

HOUSE RULES

Clubhouse - General

During Golf Season (weather dependent) the Clubhouse will be open from 9:00 A.M. to 11:00 P.M. for six days each week, from Tuesday through Sunday. These hours are subject to change and availability. The Clubhouse will be closed on Monday. Members, their families and their guests shall be properly dressed when using any of the Clubhouse facilities

Dress Code

- 1. Cutoffs, running shorts, short-shorts, tank tops, halter tops and tee shirts are not permitted at any time anywhere on the premises of the Club.
- 2. Swimming attire shall be permitted in the pool area, locker rooms and Club parking areas, provided gentlemen wear proper bathing attire, shirts and footwear and ladies wear proper cover-ups and footwear. Swimming attire shall not be permitted in any other areas of the Club.
- 3. Golf and tennis attire shall be permitted in all areas of the Club, with the exception of the Grill Room and Grill Room Terrace.

 Additionally, no golf and tennis attire shall be permitted in the Main Dining Room on Saturday evenings after 4:00 p.m.
- 4. Footwear must be worn at all times on Club grounds except the pool area and showers. Metal spikes are not permitted to be worn on Club grounds.

Mohawk Golf Club will maintain and contemporary casual dress code. Contemporary casual attire includes all "Smart Casual" attire, as well as golf attire (as defined in the Rules for Golf), tennis attire (as defined in the Tennis Rules) and appropriate denim/jeans.

Appropriate denim/jeans are defined as those properly sized and worn at normal waist height, in excellent condition and consistent in color. Appropriate denim/jeans does not include denim with holes or rips, frayed material, excessively bell-bottomed, cut-offs, denim shorts, denim mini-skirts, work-type denim, bibs, painter pants, or jeans that are worn extremely low-cut or low-slung.

All denim/jeans must be worn with casual, tasteful and appropriate shirts and shoes that comply with the Club's existing dress codes. Shirts must be tucked in unless specifically tailored for outside wear.

The Bar area, if the Clubhouse is open, will always be open to members 21 years of age and older. All dining areas are open to all ages if they are accompanied by a member 21 year of age or older.

Dining and Beverage Service

Various dining options will be available throughout the year. These hours will be largely determined by weather, events and other club happenings. Please find the standard hours of operations below. Be aware, these hours are subject to change based on availability. Food orders must be placed before the close of service periods indicated below.

Members are urged to make reservations for lunch or dinner by calling the Club Office as far in advance as possible, in order to facilitate proper service. Beverage service is available during the same times as dining services.

Other Dining Areas

All dining areas are available to members upon reservation for such events as dinners, luncheons, cocktail parties and wedding receptions. Reservations should be made well in advance through the Membership and Events Manager. A charge may be incurred for the use of these rooms if the restaurant and beverage billing is less than the minimum established by management for no-charge usage. Please contact management for details.

Locker House

During the golfing season the Locker House is open as follows*:

- No alcoholic beverage may be served on Sunday until 12:00 Noon
- During the non-golfing season, the Locker House is not open^.

Members under the age of 21 years are not permitted in the 19th Hole Room but may receive service from the 10th Tee Grill area. Children under 10 years of age must be accompanied by a member or other suitable supervisor at least 16 years of age.

Lockers are available for rental in the Men's and Ladies' Locker House areas. Bags of golf clubs may not be stored in the lockers.

GOLF COURSE RULES

Playing Privileges

Except when the Main Course or the Wee Course or both courses have been reserved for participants in a special event, such as a Member-Guest Tournament or an Interclub Match, members and their guests may play on the courses as follows:

A. Wee Course. All members with golfing privileges may play this 9-hole course at any time. Such golfing members' sons and daughters under age 10 may play on this course at any time when accompanied by a member.

B. Main Course. According to the following schedule:

Additional Golfing Rules

- **Note 1**. Men's Senior League shall have preferred starting times, on the 1st tee on Tuesdays from 8:00 a.m. to 11:00 a.m.
- **Note 2.** Tuesday Men's League(s) shall have preferred starting times when starting on the 1st and 10th tees, between 4:00 p.m. and 6:00 p.m. On the Tuesdays that the Men's League has preferred starting times on the 10th tee, non-participants shall also commence their regular round of golf from the 10th tee.
- **Note 3.** Women's League(s) shall have preferred starting time on the 1st tee on Wednesday morning, whether tee times or shotgun, from 8:00 a.m. until noon. Additional Women's League(s) shall have preferred starting times.
- **Note 4.** Weekends and Holidays, Golfing Members under 18 years may tee off before 10:00 a.m. if accompanied by a regular golfing member

over 18 years. All other Golfing Members under 18 years may tee off starting at 10:00 a.m. if tee times are available.

- **Note. 5.** On Saturdays, Sundays, and Holidays, if there are open tee times after 9:00 a.m. the Golf Shop management shall have the discretion of allowing any members to use these open tee times, but must first provide for those regular members who have started on the back nine and will be making the turn to start the front nine after 9:00 a.m.
- **Note 6.** Members' children under 10 years of age may play on the Main Course during the same hours as Golfing Members under 18 years provided the child is playing golf and is under the direct supervision of their parent who is a Full Family Golf Privilege Member. Members' children who are 10 years of age and over, and who are not golfing members, have no playing privileges except as guests.
- **Note 7.** "Open tee times" means a completely open time with slots available for four individual golfers. The entire time slot would have to be available for any Associate member to sign up for an open tee time. The Associate members would have to be over the age of eighteen and have golfing privileges.
- C. Junior/Intermediate Golfing Members may start play on the main course in accordance with the schedule contained in preceding information without parental supervision provided such member can maintain pace of play. In those cases where Junior/Intermediate Golfing Members would like a starting time while playing with other Junior/Intermediate members, tee time preference shall be given to adult members.

Main Course Play

Play on the course is conducted under the Rules of Golf of the United States Golf Association.

- Local Rules may apply at certain times and will be posted by management.

Members are urged to play in "foursomes" on weekends and Holidays, or whenever play on the course is heavy.

- Playing "fivesomes" or "sixsomes" (or more) is prohibited at all times. Unless directed by club management

Starting play on the tenth tee is prohibited except:

- A. When starting time sheets assign tenth tee starting, e.g. early A.M. on weekends or Holidays
- B. When specific approval is secured from the Golf Shop.

Etiquette on the Golf Course

Courtesy to fellow members and/or guests is a "must" at all times. Infractions of rules by anyone should be a concern to all and must be directed to the Golf Shop or club management.

"Slow Play" must be a matter of concern to all golfers.

If players/groups are proven to be consistently slow &/or falling behind during normal busy times, tee times for those players/groups will be adjusted to tee off outside the normally busy times. The Golf Shop will monitor and report consistently slow players & groups. Ideally an 18-hole round of golf for a foursome should take no longer than a total of 4 hours 10 minutes.

Starting Times

On all days, starting-time sheets are used to determine the order of starting play on the Main Course. Starting times for weekdays, weekends and holidays are secured by signing up online through your member account login on the club's website – www.mohawkgolfclub.com - or via phone through the Golf Shop.

The system will allow you to make tee times a week in advance. On Weekends & Holidays a lottery system will be used for times prior to 10am. You should put your request in online or by calling the Golf Shop prior to Friday morning. Friday at 12:00 p.m. the Golf Shop will complete the Lottery process and assign tee times for the Weekend and Holidays. The Lottery process is managed so that same group does not monopolize a similar tee time each Saturday & Sunday.

*Please note that Saturday morning between 7:45am - 8:30am are the most desirable times. If there are multiple requests for the same tee time, you will normally get your requested time within 20-30 minutes of your request. Tee times can always be viewed online after logging into your account through the website.

SPECIAL REQUESTS: If you have a special function that you must be at by a certain time, the Golf Shop will make every effort to secure your preferred tee time. With club events taking precedence, this may be difficult to accommodate all requests. Please speak with a Golf Shop

staff member by phone or in person to make such requests.

Members may go online after 1:00 p.m. Friday to see what their assigned tee time is or call the Golf Shop. Remember, the tee time you requested is not always the time you'll get, and it is your responsibility to check after 1:00 p.m. on Friday.

The first starting time of the day will vary depending on any club or outside events, the time of year as well as weather. The online tee sheet will have all blocked off tee times when the course isn't accessible. When we have shotguns or events and the course is full or partly taken, the tee sheet will be blocked off to an estimated time when the 1st/10th tee will be open for regular play. Please feel free to call the golf shop to see if the estimate has changed.

When all regular play is starting on the 1st tee, permission must be granted by the Golf Shop prior to teeing off the 10th tee. Groups making the turn, leagues/events and some maintenance procedures may prohibit play from starting on 10.

Mondays: Mondays the golf course doesn't open until 11:00 a.m. unless we have an outside event. If we have an outside event the course will open when the shotgun finishes or event finishes teeing off.

Golf Club Storage, Cleaning and Pull Carts

Provision is made by the Golf Professional for cleaning and storing golf clubs in the Golf Shop.

- Push/pull carts are available from the Golf Professional. Memberowned motorized or battery-powered golf carts, and memberowned push/pull carts need to be checked into the Pro Shop.
- Members shall not leave golf pull carts or golf bags in front of the Dining Terrace before or after playing.

Club Golf Carts

In using power golf carts members are requested to remember that these are heavy vehicles. They shall take all possible precaution to avoid damage to the golf course or golf carts, or injury to persons.

- Drive on cart paths paved with blacktop or crushed stone where such paths are provided
- Never drive through wet areas in either the fairways or rough
- Do not drive electric or pull hand carts closer than 15 yards of greens, traps and tee area,

- To expedite play, park carts to side of green toward next tee while putting or chipping to green, not in front
- When cart is left unoccupied, set hand brake
- Avoid sharp, abrupt turns, especially where people are around or on hillsides
- Avoid collisions with other carts or with trees, posts, walls, fences or other obstructions.

The Golf Course Superintendent is authorized to declare the golf course unsuitable for use of power golf carts when in his/her judgment, their use would cause excessive damage to the course, e.g. after a long, hard rain. The superintendent will notify the Pro Shop not to rent carts when such conditions prevail.

Guest

Members inviting guests for golf must register them at the Pro shop listing guests' names and city of residence.

Local residents may be admitted as guests for use of the golf facilities for a period of one day upon invitation of a member, but an individual local resident may not be admitted more than six times in one calendar year (exclusive of member-guest and interclub events).

It is further understood that this determination is the responsibility of the member. The Pro Shop will assist whenever possible. In addition, the member shall assume the responsibility of apprising the guest of club dress code as well as other applicable rules.

Non-resident guests, i.e., persons who do not have a residence or place of business in the resident area, may be admitted as guests for use of the golf facilities for one day at any time, upon invitation of a member limited to not more than ten days in any calendar year.

- *Either Local or Non-Resident Guests must be accompanied by a member while playing on the course.
 - Guest Passes for Prepaid Dues (must be paid by January 31st)
 - Guest Passes only apply to guest they may not be used by the member for their own play.
 - A guest may only play 54 holes by utilizing the guest passes of a member (cart fees apply). After the use of 54 holes greens fees and cart fees will both be applied. Each guest may play a maximum of 108 holes (equivalent of 6 rounds).
 - House Members: 90 holes of golf is included (cart fees apply).

Pro Shop Hours

During the golfing season the Pro Shop will be open during the following hours:

Monday	Closed*
Tuesday	7:30AM – 7PM**
Wednesday - Friday	7:30AM – 6PM **
Weekends/Holidays	6:30AM – 6PM**

Practice Areas

The practice range west of the ninth hole is operated by the Golf Shop & Bag Room, and during the golfing season is open ALL DAY. Members are permitted to use their own golf balls to practice with on the practice putting green.

Members' children who are less than ten years of age must be accompanied by an adult.

Additional Rules for Events

On these days the golf courses are reserved by participants in the Tournament. Members not playing in the Tournament are invited to participate in the related social activities.

Golf Attire

Proper attire for the golf course, wee course, putting greens, and practice areas is as follows:

For Men – slacks or shorts; golf shirt (both collared, mock style, or crewneck are acceptable); golf shoes or appropriate rubber-soled shoes.

For Women – golf skirts and shorts no higher than mid-thigh, slacks, golf blouse or shirt (both collared, mock-style, or crew neck and sleeveless are acceptable); golf shoes or appropriate rubber-soled shoes.

Not Permitted – blue jeans, designer jeans, halter tops, tank or tube tops, T-shirts, string-strap tops, cutoff jeans, tennis attire, or short shorts are not permitted. The style and fit of all apparel should be consistent with standards judged to be generally acceptable to the Club membership.

Golf shirts must be tucked in unless specifically designed to be worn on the outside. All shirts must cover the midriff. Members must inform their

guests of the dress code. As directed by the Board of Governors, the dress code will be enforced by golf professionals. For Juniors – same as for adults. Juniors must inform guests of dress code.

Hole-In-One Club

This club is designed to provide a source of funds to cover the expenses of a celebration honoring any golfing member of the Mohawk Golf Club, or his or her adult guest, who makes a hole-in-one on the main course at the Club.

RULES:

- 1. Each member of the Mohawk Golf Club with golfing privileges (Golf and House Members), 21 or older, will be a member of the Hole-In-One Club. Members in other membership categories are encouraged to join.
- 2. Adult guests of Club members must be playing with that member to be covered.
- 3. The person who makes the hole-in-one must be present throughout the celebration, which will begin when that person completes the round and will last no longer than two hours.
- **4**. The celebration is only covered at the Main Clubhouse bar and Terrace. No top-shelf alcohol will be included.
- **5**. Outside events (meetings, banquets, weddings, etc.) are not eligible for participation in a hole-in-one celebration. Golfing events not primarily for Mohawk Golf Club members also are not eligible for participation.
- 6. Food charges will not be included in a hole-in-one celebration.
- 7. Following the accomplishment and celebration of a hole-in-one by one or more Hole-In-One Club members or his/her adult guest, each member will be assessed a modest sum*. Each member of the Hole-In-One Club in the same family will be assessed equally. The assessment will be charged in the member's monthly bill.

*maximum bar bill will be \$2,000 total - this is the max amount that will be divided between participating members.

SWIMMING POOL RULES

The pool and facilities are available for use by Club members and their guests subject to the following rules which are for the health, safety, and enjoyment of the facilities by all who use them. Cooperation is necessary for the most effective use of the facilities. Year Pool Memberships are available for use from May-September, includes access to pool, tennis and 6 Wee Course Rounds.

Pool Operations

Every member and guest must sign in at the pool front desk. Such registration must be made daily. Members assume responsibility for informing their guests of pool rules and of signing for guest fees.

The operation of the pool facilities shall be under the complete charge of the Pool Director who shall be in control of the entire pool area and of the pool personnel. The Pool Director is charged with the enforcement of these rules and may make and enforce such additional rules as may be needed to increase the safe use of the facilities. Such additional rules, if any, will be posted in the pool area.

The Pool Director and the Lifeguards may restrict or deny the use of the pool and facilities to adults or children for misconduct or infraction of rules.

In the absence of the Pool Director, the Lifeguard on duty shall assume the status of Director.

Every precaution will be taken for health and safety and for the protection of personal belongings, but the Club is not responsible for accident, injury or loss of any kind. In the event of accidental injury or the illness of anyone using the pool, the Director and the Lifeguard are authorized to call 911 (Niskayuna Fire District #1 paramedics).

Pool Schedule

The pool shall be opened on Memorial Day weekend and closed the weekend after Labor Day*. It shall be open every day except as required for maintenance. *weather permitting

The detailed hours for use will be posted at the Main Desk and at the Pool House and updated regularly.

Swim Lesson hours are typically Monday through Friday, 12:30 p.m. to 1:30 p.m. Please inquire with the Pool Director for verification.

Specific Pool Rules

- Children under the age of 12 are not permitted to use the pool facilities without adult supervision. An adult is defined as a person at least 18 years of age. (Babysitters must be registered with the Pool Director and must provide constant supervision of the children for whom they are

responsible) Otherwise, the children may be denied use of the pool.

- Children of Club members, over 12 years of age, are permitted to use the pool.
- Children under 10 years of age who are relatives of Club members, and who reside outside of the local Capital Region area codes may use the pool without payment of guest fees but must be accompanied by Club member.
- For use of the pool by all other guests, see Guest Policies section.
- Swimmers must take a thorough hot shower with soap in the pool bath house before using the pool. (State Law.) Re-showering with soap is required after use of suntan lotion, cream, or oil before the pool may be entered.
- Pushing and running is prohibited in the pool enclosure.
- No floating devices (including life preservers, water wings, snorkels, flippers or face masks) or toys are permitted in the large pool without permission from a lifeguard.
- Groups of swimmers wishing to participate in pool games must request prior approval from the lifeguard on duty.
- Running, pushing, shoving, and horseplay are always prohibited.
- Appropriate areas for eating food are designated. No food is allowed on the pool deck.
- *No* outside food or beverage is permitted.
- Smoking is forbidden at the pool facility.
- Glass containers of any kind are always prohibited.
- Please store coolers, tennis rackets, towels, backpacks, etc. away from tables and high traffic areas so that all members can use the tables.
- Babies in diapers or children not toilet-trained are not permitted in the main pool.
- Street or other appropriate sports clothes must be worn to and from the pool and individuals in swimsuits shall not leave the pool area.
- Pets are not permitted inside the pool enclosure.
- Employees will not be responsible for members' valuables.
- Pool may be closed at any time at Pool Director's discretion for safety or sanitary reasons.

Instructions and Swim Team

Group swim lessons are available to all members at no charge. Class schedules are available at the pool.

Parents of children on the Swim Team are required to sign a permission slip at the time the child begins Swim Team practice. The permission slip also will explain the criteria to be met for the child to receive a Swim

Team trophy at the end of the season.

Guests and Guest Fees

The guest fees for swimming will be approved annually by management.

Local residents may be admitted as guests for use of the swimming pool for a period of one day upon the invitation of a member, but an individual local resident may not be admitted more than three times in one calendar year.

Non-Resident guests, outside of Capital Region area codes, may be admitted as guests at any time for a period of one day at the daily guest fee noted above, upon invitation of a member. In addition, non-resident guests under 18 years of age, upon invitation of a member, may be admitted for longer periods of time for additional guest fees.

Wading Pool (Kiddie Pool)

No child under 10 years of age will be permitted inside the wading pool enclosure without responsible supervision. Responsible supervision is defined as a person at least 16 years of age.

No more than two children per adult supervisor permitted inside enclosure. No metal toys/objects inside pool enclosure. (Rubber or safe plastic toys permitted)

No food/beverage containers in enclosure. Tight fitting, proper, swim attire required over diapers. Except for entry/exit, pool enclosure gate must always be kept closed to prevent unattended entry. Pool may be closed at any time at the Pool Director's discretion for sanitary/safety reasons.

RACQUET SPORTS RULES

Playing Privileges

All Club members may play on the tennis courts at any time, except that Junior members, those under 18 years of age, shall give precedence for the use of the courts to members of all other classes at the following times:

- Sundays and Holidays -all day
- Saturdays -after 1:00 P.M.
- Weekdays, Monday through Friday -after 5:00 P.M.

Members, 18 years of age or over, may reserve a tennis court for a prearranged match by communicating with the Tennis Director in advance.

Regulations for Play

Conventional tennis attire, including tennis shoes, shall always be worn. Cut-off jeans are not allowed. Playing on the tennis courts in bare feet or in a bathing suit are both specifically prohibited.

All persons shall stay off the tennis courts except when playing on them.

Guests and Guest Fees

The guest fees for tennis will be approved annually by management.

Members inviting guest for the use of the tennis courts must register them at the Tennis House or, in case it is not attended, at the Golf Pro Shop in the Clubhouse. NOTE: This Rule applies to Junior Members as well as to adult members of all classes.

Local residents, within Capital District area codes, may be admitted as guests for use of the tennis courts for a period of one day upon invitation of a member, but an individual local resident may not be admitted more than three times in one calendar year.

Non-resident guests, outside of Capital District area codes, may be admitted as guests for use of the tennis courts for one day at any time, upon invitation of a member.

BRIDGE RULES

Playing Privileges

All Club Members are invited to participate in the Club's bridge activities.

Fees

A modest fee will be charged to each player in all events to pay for prizes and expenses.

Regulations of Play

Both Duplicate Bridge and Contract Bridge are played generally in accordance with the rules set forth by the American Contract Bridge League.
